

Declaration of Consent to Photo and Film Recordings of your Child and to the Surf Park Regulations

If your child comes to the surf park o2 SURFTOWN MUC with you, another adult or unaccompanied by an adult for surfing or bodyboarding, we not only want to offer great surf or bodyboard sessions, but also make your child's day with us an all-round experience from which you can take photos or videos of the rides home with you. We therefore ask you to give your consent to our collection and processing of your child's personal and sensitive information as set out below. With your signature, you also declare that you agree to your child visiting the surf park, that you have taken note of our surf park regulations (<https://surftown.de/en/surfpark-regulations>) and that you have informed your child of their content, the obligation to comply with them and, in particular, the risks of surfing and bodyboarding.

We have the entire surf or bodyboard session photographed by a photographer and filmed by a video system installed at the wave pool. All surfers and bodyboarders are photographed or recorded on video and then the respective images and videos are individually assigned to your child and the other participants in your child's surf or bodyboard session with the help of the software-based evaluation of the participants' physical characteristics. In this way, with the support of artificial intelligence, a photo and video file from your child's rides in the respective surf or bodyboard session is created by the third party engaged by us, Flowstate Zone Pty Ltd. Such file only contains recordings of your child ("Session Film") and is stored for a period of 30 days on Flowstate Zone's platform that is only publicly accessible to a limited extent ("Platform"). We will show clips from the surf or bodyboard session and possibly the Session Film on monitors or similar devices in the surf park. You will also receive an email with an internet link to the Platform, where you can access the Session Film after registering with Flowstate Zone, watch it with your child and then decide to purchase it. Via a corresponding link, all other participants in your child's surf or bodyboard session also have access to all files stored on the Platform for this surf or bodyboard session and could therefore also access the Session Film intended for your child. We will ask all participants to view and purchase only the surf or bodyboard session film that contains the footage of the respective participant. However, we cannot guarantee that all participants will adhere to these guidelines. However, please be assured that neither your nor your child's name or any other personal data of you or your child will be published by us, not even as source text to the photos and/or videos. We will not publish the photos or videos of your child's rides or their Session Film in print media, on websites, in social media or other publications, nor will we use them for advertising or marketing purposes. The Session Film with the recordings of your child will be automatically deleted after the storage period of 30 days has expired.

Declaration of Consent:

As parents, I/we consent to my child visiting the surf park o2 SURFTOWN MUC. In the event that I/we have booked a surf- or bodyboard session in the levels First Timer, Rookie, Progressive, Intermediate or, Advanced for my child aged between 6 and 10 I/we confirm that my child is able to (a) swim continuously for 20 minutes independently and cover at least 400 meters in this time, 300 meters of which in the prone or supine position and 100 meters in the other body position, (b) dive twice in a row to a depth of 2 meters to retrieve an object, e.g. a small diving ring, (c) complete a 10 meter distance dive, (d) complete a jump from a 3-meter diving board; as well as that my child has the necessary skills and experience for this session. I/we also agree that the members of the Surftown GmbH team have the authority to exclude my/our child from (further) participation in the session at any time should they come to the conclusion that my/our child is not up to the requirements. With reference to **§10(6) and §10(7) of the surf park regulations**, examples of exclusion are: (a) my/our child fails three consecutive attempts to get a wave on their own; (b) my/our child is not leaving the danger zone, e.g. after takeoff, within two waves; (c) my/our child being in the water poses a danger to my/our child itself and/or others. In this case, there is no entitlement to a full or partial refund of the ticket price. I/we also consent that Surftown GmbH has photos and videos of my/our child taken during surfing or bodyboarding as part of surf or bodyboard sessions, has them processed for the purpose of assigning and compiling recording sequences of his/her rides into a Session Film and has them stored on the Platform for 30 days. We/I also consent to the presentation of clips from the surf or bodyboard session as well as, if applicable, the Session Film on monitors or similar devices in the surf park. We/I also agree Surftown GmbH shares my/our email address(es) and the email address of my/our child as personal data with third parties engaged by Surftown GmbH and acting on its behalf to provide the Platform, including to Flowstate Zone Pty Ltd. As parents, I/we provide our consent as set forth in the declaration of consent above and consent to making the Session Film available to the public on the Platform for the purpose of viewing and purchasing the recordings of my/our child's surf or bodyboard session, whereby both the viewing and purchase of my/our child's Session Film would also be possible for the other participants in the surf or bodyboard session.
